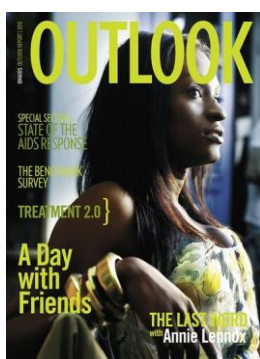
《世界卫生组织农药毒性分级推荐标准》首次出版于 1975 年，为世界卫生组织年鉴之附录，出版后广为各国采用，并于 1978 年第一次出版该建议的指引，其后每隔数年则酌情修改再发行。鉴于化学品的广泛开发与使用，各个国家有其作法以确保使用、运输和处置的安全性，涉及之范围相当广泛，因此体认到要采用国际调和的做法进行分类和标示，可为此类方案提供基础，尤其是危害化学品（hazardous chemicals）使用及其安全管理。联合国「危险物品运输专家委员会与化学品全球分类与标示调和制度专家委员会（UNCETDG/GHS）」于 2002 年 12 月公布了「化学品全球分类与标示调和制度（The Globally Harmonized System of Classification and Labelling of Chemicals, GHS）」，是为世界各国在推展 GHS 上的重要参考指引。

除了考量农药/杀虫剂之急毒性之外，世界卫生组织参考 GHS 之口服急毒性与皮肤急毒性之急毒性危害物质分类内容，并将对健康的严重危害列为重点，适度地修改对农药/杀虫剂之分类。文件的内容分为两部分，第一部分为世界卫生大会建议的农药/杀虫剂分类的规范原则，世界卫生大会决议案考虑到分类的条件将随着时间与经验的累积而发展，是以于 1975 年提出时即与 GHS 的急毒性危害物类别共同发展，该规范原则仍持续应用至今；第二部分是依危害性对农药/杀虫剂之分类建议指引，以表格方式列出极剧毒（extremely hazardous）、剧毒（highly hazardous）、中等毒（moderately hazardous）、轻毒（slightly hazardous）以及正常使用下不太可能呈现急性危害的活性成分。

书中提及之危害为影响健康的急性风险，而基于生物性资料的分类并非一成不变，因意见相左而影响生物性资料的评估是无可避免的，而毒性资料的歧异性与不一致也可能肇因于实验动物的易感性、或评估时采用的实验技术与材料之不同而异；分类条件所提供的资讯乃为补充原分类不足的部分，而非取代专有知识或可靠的临床判断，因此，需视实际情况而重新评估与审定。分类原则乃基于毒理学之标准程序而决定，主要以大鼠试验之急性口服毒性与急性皮肤毒性为判定标准。

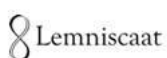
